

# California Consumer Privacy Act Notice

Thank you for visiting the DESRI's website and viewing this California Consumer Privacy Act Notice (this "**CCPA Notice**"). When we collect personal information from California residents we become subject to, and those residents have rights under, the California Consumer Privacy Act ("CCPA"). This CCPA Notice supplements our [Privacy Statement](#) and is used to allow us to fulfill our CCPA obligations and explain your CCPA rights. For purposes of this CCPA Notice, the words "you" and "your" mean only such California residents. Certain terms used in this CCPA Notice have the meaning given to them in the Privacy Statement.

This CCPA Notice is effective January 1, 2022

## What Personal Information Did We Collect from California Residents?

We collected the following categories of personal information within the last 12 months:

- **identifiers** such as name, address, IP address, and other similar identifiers;
- **personal information under the Customer Records provision of the California Civil Code** such as a name, address, and telephone number;
- **characteristics of protected classifications** such as gender and citizenship status;
- **commercial information** such as fund subscriptions;
- **biometric information** such as fingerprints;
- **internet/electronic activity** such as browsing history and search history;
- **audio, video, electronic** or other similar information;
- **professional or employment related information** such as job history and performance evaluations; and
- **education information.**

## What Personal Information did we disclose for a business purpose?

We may have disclosed the categories of personal information listed above for one or more business purposes permitted by the CCPA during the last 12 months.

## What Personal Information did we sell?

We do not sell, and within the last 12 months have not sold, personal information to third parties.

## What sources did we obtain Personal Information from and why did we collect it?

## Rights of California Residents

You have certain rights under the CCPA as described below. We would like you to know that if you exercise these rights, we will not discriminate against you by treating you differently from other California residents who use our website but did not exercise their rights.

- **Right to Know**—the right to request that we disclose to you, specifically beyond the general statement immediately above, the categories and specific elements of personal information collected, including the source of the information, our use of it, and, if the information was disclosed or sold to third parties, the categories so disclosed or sold as well as the categories of third party who received or purchased it.
- **Right to Request Deletion**—the right, under certain circumstances, to request that we delete the personal information we collected from you.
- **Exceptions to Rights**—in some cases, we may be unable to accommodate your request. For instance, we will deny your request if we are unable to authenticate your identity or your ability to submit the request on behalf of another individual. Additionally, we will not honor your request if an exception applies, such as when disclosing Personal Information would jeopardize another consumer’s rights and freedoms or where the Personal Information, we retain about you is not subject to the CCPA’s access or deletion rights.

We will make every effort to respond to all verified requests within 45 days, as required by the CCPA. If we require an additional 45 days to process your request, we will provide you with an explanation.

You, or an authorized agent acting on your behalf, can exercise the Right to Know up to two different times every 12 months. The CCPA only allows us to act on your request if we can verify your identity and/or your agent’s authority to make the request, so you will also need to follow our instructions for identity verification.

If you make a verifiable request in accordance with the above, we will confirm our receipt and respond to your request in the time frames prescribed by the CCPA.
